All Competitors / crew members

The Stewards, having become aware of an incident, summoned the above crew members as well as the competitor's representative, have considered the following matter and determine the following:

Facts The crew of car No. 20 OLIVER SOLBERG / ELLIOTT EDMONDSON performed

exhibition driving ("drifting") on the way from the final podium to the Parc Fermé in the

Principality of Monaco.

Offence Breach of:

- Art. 34.1.3 of the 2025 FIA WRC Sporting Regulations

- Art. 12.18 of the Supplementary Regulations of the Rally

- Art. 12.2.1.h of 2025 FIA International Sporting Code

**Decision** 5-minute time penalty on the Competitor of car No. 20 PRINTSPORT in accordance

with Article 12.18 of the Supplementary Regulations of the Rally.

**Reason** A hearing was held by phone with the driver of car No. 20, Mr. OLIVER SOLBERG,

on Sunday 26th January 2025 at 19.30 hrs.

The Stewards reviewed video evidence. The incident happened on the road section on the way from the final podium in the Principality of Monaco, in the corner "Fairmont".

The driver admitted that he was driving sideways in front of spectators. The driver apologised for his lapse, adding that in his opinion he did not create an unsafe situation.

The Stewards examined the case in detail and concluded that a potential unsafe situation was created as a turn was approached in a "drifting" mode by the driver of car No. 20 and many people were standing up at that turn.

Art. 12.18 of the Supplementary Regulations of 93<sup>e</sup> Rallye Automobile Monte-Carlo stipulates that exhibition driving is strictly forbidden **everywhere** due to lack of suitable place.

The Stewards, therefore decided that the driver of car No. 20 did not respect the relevant regulations and applied the above-mentioned time penalty.

Competitors are reminded that they have the right to appeal certain decisions of the Stewards, in accordance with Article 15 of the 2025 FIA International Sporting Code and Chapter 4 of the FIA Judicial and Disciplinary Rules.
